Much of the UK Construction industry is built on "credit" from a combination of suppliers or subcontractors in the first instance operating under adverse payment terms and then receiving delayed or late payment and an undervaluation of their work.

It does not have to be this way!

The key to improving your cash flow particularly for those with a high material content is for the payment terms to include provision for payment of material off-site.

Provided your argument is both reasoned and realistic the Main Contractors representatives only objection can be that either they are concerned about the security of their payment to you for materials off-site or alternatively they or their client do not have the funds or the cash flow to pay you when you require.

The objection regarding security of payment for material off-site is relatively easily over come by offering the vesting of materials off site with the use of vesting certificates legally transferring ownership to the person or company paying you.
