Payment Terms

It is essential that all parties have an unambiguous documented understanding of the agreed payment terms. Payment terms need to be negotiated free from discounts to include agreed amounts against 'milestone' work done including payment for materials off site.

Retention

Retention has a serious effect on your cash flow and profitability. We at **FRESH** believe that in many contracts no Retention deductions can be negotiated. If retention is agreed as a last resort it is essential that there are clearly defined calendar dates for the release of retention deductions.

Limit of Liability

It is essential in any contract that you limit the extent of your liability. The 'headline' risk is Liquidated and Ascertained Damages, however this is not the only risk to your business.

When negotiating the contract, you need to ensure that in addition to Liquidated and Ascertained Damages you also limit any liability for consequential loss, contra charges and a host of other potential costs and claims the Main Contractor may look to recover from you.

Programme

Your programme periods or dates together with notice to start on site must be clearly defined and agreed at the outset. As we all know construction programmes do not go to plan and you must have the fundamental right to vary the programme or site works if for any reason outside your control you are delayed. Allow us at **FRESH** to negotiate provision for this right to ensure you are free from risk of claims for delay and even negotiate your abortive costs.

Dispute Resolution

It is an unfortunate fact that in construction disputes occur and our "Theory into Practice" goes a long way to avoiding disputes and will ensure that you are protected with the appropriate documentation in the event of a dispute occurring. The last of the "FRESH Fundamental Five" is to ensure that bound into any contract is a quick cost effective Dispute Resolution Procedure before any dispute is escalated to legal advisors, lawyers, adjudication
